Note:

- 1. As per the Water Act, 2016 Section 85. (1) A person **SHALL NOT** provide water services except under a licence issued by the Regulatory Board, upon submission of an application and such supporting documents as the Board may require. (2) A person who provides water services in contravention of this section commits an offence.
- 2. Where a licensee, without due cause, fails to submit a complete application for renewal of a licence on time, the Regulatory Board may place the licenced water services provider under a special regulatory regime pursuant to section 30 of the Water Services Regulations 2021 and in accordance with section 102 of the Water Act 2016.
