CEO'S MESSAGE

s we continue to strengthen the regulatory framework for the water service, the last part of the year saw a number of key guidelines developed and operationalised.

WASREB continued to discharge its mandate in a favourable atmosphere judging from the willingness of Water Service Providers to comply with regulation and the fruitful engagements with County Governments that own them.

Five Counties opened their doors to allow the Regulator assess their utilities and chart the way forward. Surfice is it to say that these were newly elected Governors. Kisii/Nyamira, Bungoma, West Pokot, Trans Nzoia and Uasin Gishu leadership outlined their vision and urged WASREB to guide in implementation of water and sanitation provision projects identified.

On regulation, WASREB worked hand in hand with development partners to bring on board utilities. Water Works Development Agencies and Counties to capacity build and expose them to various tools developed to guide the sector. Key guidelines disseminated during the period included Guideline on Provision of Water Services in the Rural and Underserved Areas, a tool that is helping the Regulator report on water service coverage nationally, the Water Governance Training Handbook meant to standardise the training given to oversight bodies namely Boards of Directors in Water Service Providers and Counties and Non-Revenue Standards which are geared towards helping WSPs manage the water losses hence improving on their turn over.

As we look to the future, our interest is on the licencing of all WSPs operating in the country. Over 80 utilities have so far been licensed laying a foundation for well managed entities/services with serious commitment and responsibility for consumer/customer satisfaction.

WASREB PARTICIPATES IN ASK SHOWS

WARIS DATA COLLECTION TAKES PLACE ACROSS THE COUNTRY

ARIS data collection exercise was successfully held across the Country. Participants from utilities under the nine Water Works Development Agencies met in main centres namely; Eldoret and Naivasha under close supervision of Team WASREB. The Regulator uses the WARIS platform to verify data from utilities in preparation for IMPACT Reports. Issue 15 is coming up covering financial years 2021/2022.

The information is weighed using key performance indicators including, Water Coverage, Sanitation Coverage, Non-Revenue Water, Water Quality, Hours of Supply, Metering among others.

LICENCE PUBLIC CONSULTATIONS HELD IN 10 COUNTIES





ASREB conducted 12 public consultation meetings for licensing of various Water Service Providers across 10 Counties between July and December. These were; Nairobi, Naivasha, Nyandarua, Mutitu, Mathira, Ol Kejuado, Rukanga, Kitui, Mbooni, Wote, Kibwezi-Makindu and Gusii.

Various stakeholders, staffs, management teams of the WSPs, local government officials and county chiefs attended the meetings where various issues and topical concerns were addressed substantively.

Some needed assurance that areas which lack water will be taken care of, sanitation services will be prioritized and that the WSP will improve overall performance. WASREB also sensitized participants on their rights to water, importance of licensing, good governance among other issues.

At the end of the meetings, stakeholders resolved and agreed that WASREB should license their various WSPs in order for them to continue with the service delivery.

The meetings were held in strict adherence to Ministry of Health Guidelines on combating the prevailing COVID-19 pandemic.

TARIFF PUBLIC CONSULTATIONS HELD TO GET CONSUMERS' VIEWS

ASREB has the regulatory mandate to determine and review water and sanitation tariffs in Kenya, with the overarching goal of consumer protection. The regulator acts as a referee to offer confidence to all stakeholders of clear, transparent and stable rules in the process.

In this regard, WASREB in conjunction with utilities held four public consultation meetings on tariff adjustment of Nairobi, Limuru, Kangundo-Matungulu and Nyasare WSPs before the year ended. Stakeholders participated by giving their views on tariff adjustment. The events moderated by WASREB, were attended by a cross section of stakeholders. They resolved that WASREB should approve the proposed changes in the WSPs tariffs.

GOVERNANCE ISSUES DOMINATE DISCUSSIONS WITH COUNTIES





ASREB Management embarked on implementation of а turnaround strategy of poorly performing Water Service Providers by engaging with them together with their County Governments with the objective of understanding what ails them and where they propose WASREB to assist them so as to improve. This is in tandem with the Board's current County Engagement Strategy.

In this regard, County Engagement Activities were held in 5 Counties namely; Kisii/ Nyamira on 5/12/2022, Bungoma-6/12/2022, West Pokot- 7/12/2022, Trans Nzoia and Uasin Gishu- 8/12/2022. Governors, Deputy Governors, CECMs and Chief Officers- Water Affairs, L.Victoria South, L.Victoria North, North Rift Valley WWDAs and Water Service Providers that serve under them attended the meetings. Issues on performance, governance and last mile connectivity were discussed.

A number of topical concerns were addressed and intensively discussed. These included:

- Challenges and opportunities of rural water supply
- Legal and regulatory framework for water services
- Entrenching regulatory instruments and licensing in rural water services

REGULATORY ACTS

CAPACITY BUILDING AND DISEMMINATION WORKSHOPS FOR UTILITIES HELD







ASREB in conjunction with SNV Kenya held a three-day Capacity Building workshop for Water Service Providers on Regulation and Licensing Conditions as per Water Act 2016 at Alps Hotel in Nakuru from 6-8/9/2022. Present were County Water Departments and WSPs from Samburu, Baringo, West Pokot and Mandera Counties. Participants were taken through Governance, Risk and Compliance issues in plenary sessions and group discussions.

WASREB held a two-day compliance workshop for Water Service Providers in Tana and Northern regions in Embu GTI from 14-15/12/2022. Thematic topics including; process of licensing, tariff application, curbing Non-Revenue Water, Governance are being discussed in an in-depth manner. County representatives were in attendance.

WASREB in conjunction with WSUP Kenya held a 2-day workshop from 13-14/7/2022 on dissemination of Sanitation guideline for utilities at Pride Inn Paradise hotel, Shanzu, Mombasa. Participants included Kisumu, Nakuru,

Malindi, Naivasha, Mavoko, Mombasa and Nairobi WSPs, Council of Governors (CECMs Caucus), Ministry of Water Sanitation and Irrigation, Water Sector Trust Fund, WASH-FIN, Sanivation, Kenya Private Sector and Sanergy Kenya Ltd Participants include Kisumu, Nakuru, Malindi, Naivasha, Mavoko, Mombasa and Nairobi WSPs, Council of Governors (CECMs Caucus) from 5 Counties, Ministry of Water Sanitation and Irrigation,Water Sector Trust Fund, WASH-FIN, Sanivation, Kenya Private Sector and Sanergy Kenya Ltd.

A joint sector review workshop on water service provision in Kenya took place at Kenya School of Monetary Studies, Nairobi from 21-22/7/2022. WASREB in conjunction with UNICEF Kenya, organized the two day event to review with the National and Nakuru, Homabay and Nairobi Governments together County with Water Works Development Agencies, on responsiveness of the sector to efficient delivery of services. Five Utilities serving the regions are in attendance. They also provided feedback on key performance indicators in IMPACT 14 Report.

WASREB in conjunction with WSUP Kenya, organized a 1-day workshop to review Sanitation and Consumer Engagement Guidelines at Sovereign Hotel, Kisumu on 14/10/2022. They discuss the Proposed Roadmap for WASREB's Sanitation Key Performance Indicator to be included in IMPACT Reporting. The team looked at the draft sanitation KPI roadmap, as well as, the Consumer Engagement Guideline which is to be revised.
