

PUBLIC CONSULTATION MEETING ON LICENSE & TARIFF ADJUSTMENT

The Water Services Regulatory Board (WASREB) has received applications for water services retail licences and tariff adjustments pursuant to Section 72(1)(b) and (c) of the Water Act, 2016. The proposed tariffs are intended to enable full cost recovery, ensure sustainable service delivery, and support critical investments aimed at improving water services. The applications have been submitted by the following Water Service Providers (WSPs):

1. Kericho Water and Sanitation Company Limited (KEWASCO)
2. Bomet Water and Sanitation Company Limited (BOMWASCO)
3. Wajir Water & Sewerage Company Ltd (WAJWASCO)

In addition, Lake Victoria South Water Works Development Agency (LVSWWDA) has submitted an application for bulk water supply licensing and tariff approval for the operation and management of the Itare–Litein Water Supply System, and the supply of bulk water to KEWASCO and BOMWASCO, pursuant to Section 68A(1) of the Water (Amendment) Act, 2024.

Therefore, in compliance to WASREB principal object under the Water Act 2016 Section 70(1)–“**protection of the interests and rights of consumers in the provision of water services**”, Section 87(1)– “**An application for a licence and tariff shall be subject to public participation**” read together with the provision of Section 139, we hereby notify the public of upcoming consultation meetings. These meetings will provide stakeholders an opportunity to express their views on licensing, service delivery, tariff adjustments and potential service improvements.

Please note that the Water Service Providers and Water Works Development Agency shall hold hybrid public consultation meetings (physical and virtual) as outlined below.
